

Our Purpose

To provide educational scholarships for Coachella Valley students in the Hospitality Accounting, Finance and IT field

HFTP Southern CA Desert Chapter is committed to the education and development of students interested in pursuing a career in Accounting, Finance and IT. HFTP Southern CA Desert Chapter has scholarships available that are renewable annually. Our scholarships range from \$500 to \$1500 per award per year. Applicants must be from the Coachella Valley; who are high school graduating seniors, or currently enrolled in junior college or at an accredited University actively pursing a degree in Accounting, IT or Finance. Continuing education in the accounting, finance and IT field for working adults will also be considered. HFTP Southern CA Desert Chapter has the ability to provide grants to schools in the Coachella Valley for education in finance, accounting and IT.

Our Requirements

(note our guidelines changed in 2019)

- The Applicant must be studying Accounting, IT and/or Finance.
- The Applicant must hold a minimum 3.0 GPA or higher.
- HFTP Southern CA Desert Chapter members holding a management position (Controller, Accounting Manager, etc.) are not eligible to apply.
- Children of HFTP Southern CA Desert Chapter Members are eligible, if they are studying Accounting, Finance and IT.
- Applicants must be up to juniors in college.
- High School Seniors are eligible.

Checklist of Scholarship Submission

- 1) Completed Scholarship Application
- 2) Two Letters of Reference
- 3) Essay

Please note, first letter of reference must be from College Professor, Administrator or Teacher.

Second Letter must be from a personal reference or a supervisor/manager.
